WAIVER AND RELEASE OF LIABILITY

Dragoo and Dragoo Adventures LLC dba Dragoo Adventure Rider Training (DART)**, the negligence of the participants, the negligence of others, accidents, breaches of contract, the forces of nature or other causes. These risks and dangers may arise from foreseeable or unforeseeable causes; and (d) by my participation in these activities and/or use of equipment, I hereby assume all risks and dangers and all responsibility for any losses and/or damages, whether caused in whole or in part by the negligence or other conduct of the owners, agents, officers, or employees of or of **Bill R. If I have brought a motorcycle to use in the course, I also agree that this release applies to any damage that occurs to it during the course.
